**Position: Peer Recovery Specialist** 

Focus area: Life House Collaboration with justice involved up to 25 years old

Geographic area: RAD service area

Hours: 40 hrs./week

Classification: Non-exempt Supervisor: Program Director

As a RAD Peer Recovery Specialist, you will work in collaboration with Life House, to deliver peer-based services, applying harm reduction, trauma informed and person-centered approaches to young people who have criminal justice involvement, experiencing homelessness or at risk of homelessness in public and/or community living. As a Peer Recovery Specialist, you will have a sound knowledge base of resources, the recovery community and be someone who will work collaboratively, is inspiring, open minded, and authentic.

The Peer Recovery Specialist should possess a thorough understanding of community culture, to address the barriers to successful recovery and will have the capacity to collaborate and facilitate access and connection to community resources and act as a knowledgeable resource to assist with navigating barriers and may provide links to recovery community resources and recovery options.

## **Essential Functions**

- Work with RAD and Life House team to provide education and awareness to eliminate stigma associated with substance use disorder and recovery in the criminal justice system.
- Utilize technology to introduce RAD services and provide peer-based recovery support to
  individuals with criminal justice involvement, in SLC jail/AJC/NERCC, and throughout
  reentry.
- Build relationships with youth (ages 16 through 25) to facilitate a warm handoff to Life House upon release.
- Provide peer-based recovery support (in person, virtual, telephone) to target population.
- Create connection with individuals in target population to provide recovery support, recovery and transition planning, recovery capital building, and facilitate connections to community resources.
- Conduct site-based and outreach to individuals who have self-identified concerns with substance use issues and/or co-occurring disorders to connect them with a Peer Recovery Specialist.
- Encourage frequent engagement with peer recovery specialists and other on-site recovery supports.
- Assist individuals in target population with judgement free support and educate and provide access to community resources (transportation, housing, insurance navigation, naloxone, sterile supplies).
- Provide transportation to essential appointments if necessary.
- Respond to crisis situations following outlined procedures including proper notification, documentation, and programmatic follow up.
- Serve as a liaison between the recovery community, community agencies, providers, governmental agencies.
- Perform data entry to ensure accurate recordkeeping and reporting systems (Apricot, etc.)
- Complete program-related documentation and reporting on-time and accurately.
- Promote and participate in recovery targeted awareness and educational opportunities
- Participate in additional training as required.
- Contribute to a positive and inclusive work environment.
- Maintain confidentiality of all client information.

- Comply with organizational policies.
- Perform other duties as assigned.

## **Competencies**

- Ability to work and problem solve independently and work as a team.
- Maintains a current knowledge of the roles and responsibilities of peer recovery support specialists/recovery coaches.
- Must possess a thorough understanding of peer-based recovery support services and be able to apply this knowledge in different settings.
- Understands and supports multiple pathways of recovery and is willing to embrace a person-centered approach that recognizes an individual's preferences and autonomy.
- Robust advocacy skills along with knowledge of community-based services, resources, and the local recovery community.
- Must be able to maintain appropriate boundaries in a variety of settings and situations.
- Ability to maintain effective working relationships with colleagues, peers, families, and staff.
- Demonstrates an ability to actively listen and respond to questions and concerns of members, and other stakeholders.
- Ability to manage confidential information.
- Strong cultural competence and experience working with diverse communities.
- Ability to provide accurate feedback without judgment or discomfort.
- Flexibility to adapt to unforeseen needs or circumstances.
- Practices discretion in all aspects of the job.
- Excels at problem solving and multitasking, is organized, efficient and goal directed.
- Excellent interpersonal, written, and verbal communication skills.
- Effective use of the Internet, Microsoft Office programs such as Word, Excel, PowerPoint, and Outlook.

## **Minimum Qualifications**

- Completion of a Recovery Coach Academy or equivalent 46+ hour training.
- Minimum of 2 years continuous recovery.
- Broad knowledge of and experience with Peer Recovery Support Services.
- Valid Minnesota driver's license (ability to obtain within 6 months), access to a vehicle with adequate liability insurance.
- Background check required.

## **Preferred Oualifications**

- Knowledge of the recovery community and community resources.
- Personal or professional experience with juvenile or adult criminal justice system and/or housing instability.
